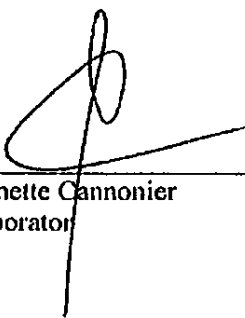
ARTICLE VI - INCORPORATOR

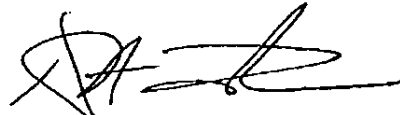
