### ARTICLES OF INCORPORATION of BRYAN R. CLEVELAND, P.A.

#### **ARTICLE I - CORPORATE NAME**

The name of the Corporation shall be: BRYAN R. CLEVELAND, P.A.

#### ARTICLE II - PRINCIPLE PLACE OF BUSINESS AND MAILING ADDRESS

The initial principal office and mailing address of the Corporation shall be:
