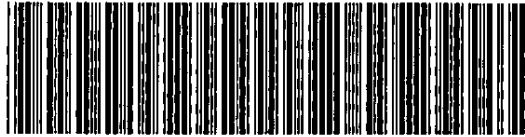

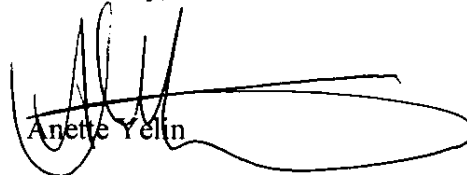

The undersigned incorporator does hereby make, subscribe, file and acknowledge these Articles of Incorporation for the purpose of organizing a Florida corporation under Chapter 607 of the Florida Statutes.

ARTICLE I
