# Attachment to Certificate of Incorporation of Global Leadership Coaching, Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 15,000 of which 10,000 shares of par value \$0.01 per share shall be designated as Common Stock and 5,000 shares of par value \$0.01 shall be designated as Preferred Stock.
