# ARTICLES OF INCORPORATION OF ESTHER STREET PROPERTIES, INC.

The undersigned, acting as incorporator of Esther Street Properties, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

## ARTICLE I. NAME

The name of the corporation is Esther Street Properties, Inc.

## **ARTICLE II. ADDRESS**

The street address of the corporation is 100 Intermodal Drive, Chalmette, Louisiana 70043.

# ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon filing these Articles of Incorporation.

#### ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

## ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.

#### ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

#### ARTICLE VII. INITIAL BOARD OF DIRECTORS

The corporation shall have one director initially. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one. #### ARTICLE IX. BYLAWS
