The undersigned natural person, who is licensed or otherwise legally authorized to engage in the painting business in the State of Florida, hereby associates himself with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation.

# **ARTICLE I**

# **Effective Date**

The date when the corporate existence of this corporation shall commence shall be April 13, 2015.

# ARTICLE II

#### Name


