#### ARTICLES OF INCORPORATION.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I. CORPORATE NAME.

<u>Capital:</u> The amount of capital with which this corporation will begin business shall not be less than \$500.00.


