The undersigned, acting as an incorporator of Voluptuous Beauty Couture Inc. in compliance with Chapter 607
and/or Chapter 621 F.S (Profit) adopts the following Article of Incorporation.

ARTICLES I NAME

The name and address of this principle corporation is Voluptuous Beauty Couture Inc.

The corporation is organized pursuant to the FLORIDA profit Corporation Code.

ARTICLE II

COMMENCEMENT OF EXISTENCE

The duration of this corporation shall be perpetual. The existence of the corporation will commence on the date of
filing of these Article of Incorporation.

ARTICLE III

PURPOSE

To establish and operate a complete full service networking group under the name of Voluptuous Beauty Couture


