# ARTICLES OF INCORPORATION OF CK FIORE-BROOKS, P.A.

ARTICLE I.

**NAME** 

The name of this corporation is CK FIORE-BROOKS, P.A.

ARTICLE II.

## **PURPOSE**

This corporation is organized for the purpose of rendering professional veterinary services and engaging in and transacting all other business not in conflict with said purpose as may be permitted under the laws of the State of Florida.

#### ARTICLE III.

## PROFESSIONAL CORPORATION RESTRICTIONS

This corporation shall be a professional corporation governed by the provisions of Chapter 621, Florida Statutes. This corporation shall not issue its capital stock to anyone other than an individual who is duly licensed or otherwise legally authorized to render professional veterinary services. No shareholder of this corporation may enter into a voting trust agreement vesting another person with the authority to exercise the voting power of any or all of that person's stock. No shareholder of this corporation may sell or transfer his or her shares of capital stock of this corporation except to an individual or entity that is eligible under the provisions of Chapter 621, Florida Statutes, to be a shareholder of a professional corporation providing veterinary services. If any officer, shareholder, agent or employee of this corporation who has been rendering professional service to the public becomes legally disqualified to render such professional services within this state or accepts employment that, pursuant to existing law, places restrictions or limitations upon that person's continued rendering
