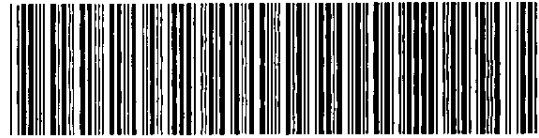

FOR
