**ARTICLES OF INCORPORATION  
OF  
SOLUTIONS 2 GO MANAGEMENT INC.**

**ARTICLE I – NAME AND BUSINESS ADDRESS**

The name of this Corporation is Solutions 2 GO Management Inc. Its principal office address and business mailing address is 3200 N.W. 67<sup>th</sup> Street, Building 2, Suite 200, Miami, Florida 33122.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III – PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

**ARTICLE IV – CAPITAL STOCK**
