ARTICLE I - NAME

The name of the corporation is Authentic Events, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

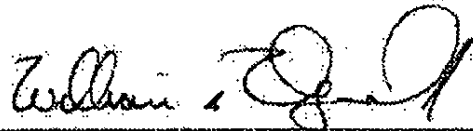

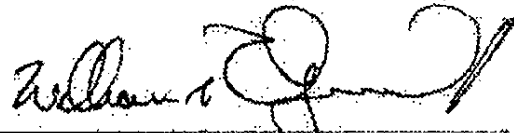
