

ARTICLES OF INCORPORATION

OF

PAUL BLATT ENTERPRISES, INC.

In compliance with the requirements of Chapter 607 of the Florida Statutes, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I. NAME

The name of the Corporation shall be PAUL BLATT ENTERPRISES, INC. (the "Corporation")

ARTICLE II. PRINCIPAL OFFICE
