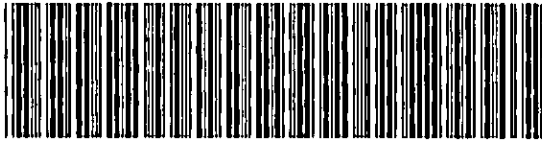

ARTICLES OF MERGER between Willsonet, Inc. a Florida corporation ("Willsonet") and Cyber Security Solutions, Inc., a Delaware corporation ("CSS").

Pursuant to s. 607.1105 of the Florida Business Corporation Act (the "Act"), Willsonet and CSS adopt the following Articles of Merger.

1. The Agreement and Plan of Merger dated February 24th, 2022, between Willsonet and CSS was approved and adopted by the shareholders of Willsonet on February 24th, 2022 and was adopted by the shareholders of CSS on February 24th, 2022.




