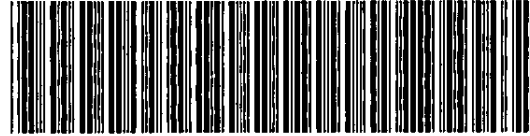

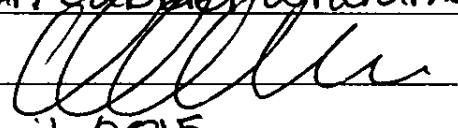

To Incorporate, in accordance with 607.0120, F.S., Dean Gabriel Williams
Consulting of Miami, a For Profit Corporation in the State of Florida

Articles of Incorporation | DGW Consulting of Miami, Inc.

- I. The official name of the Corporation shall be Dean Gabriel Williams Consulting of Miami, Incorporated ("the Corporation").
- II. The Corporation shall be allowed to operate under any of the following name variants: DG Williams Consulting of Miami, Inc., D.G. Williams Consulting of Miami, Inc., DGW Consulting of Miami, Inc., and Williams Consulting of Miami, Inc.
- III. The physical address of the Corporation shall be 2714 North Albany Avenue, Unit A - 1, Tampa, Florida, 33607.
- IV. The mailing address of the Corporation shall be Post Office Box 4953, Tampa, Florida, 33677.
- V. The purpose of the Corporation shall be to provide professional advice to organizations and individuals for a fee.
- VI. The Corporation hereby acknowledges that by filing these Articles of Incorporation with the Division of Corporations of the state of Florida, it revokes its right to use the fictitious name Williams Consulting (Florida Document Number G14000020991) to conduct business.
- VII. The number of Shares the Corporation is authorized to issue is one (1). This Sole Share of Corporation Stock shall be the Controlling Stock of the Corporation. The Par Value of this Sole & Controlling Share of Stock shall be \$0.01.
- VIII. The Sole & Controlling Share of Stock of the Corporation shall be held by Dean Gabriel Williams Enterprises, Incorporated.
