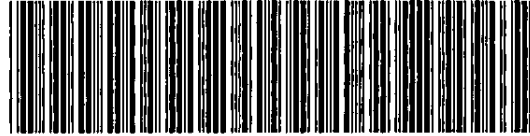

The undersigned subscriber to these Articles of Incorporation hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be: PERFECT CUT OF PINELLAS, INC. The principal place of business will be 7114 60TH WAY, PINELLAS PARK, FL 33781-4123.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

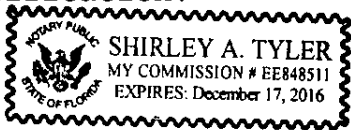
