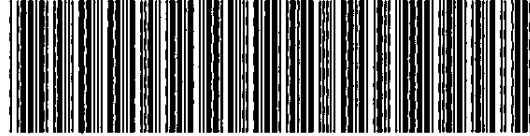

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.*

**ARTICLE I: NAME**

The name of the corporation shall be: **MY FRIEND CAROLINE, INC.**

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 1231 Grove Park Drive, Orange Park, FL 32073.

**ARTICLE III: EXISTENCE AND DURATION**

This corporation shall exist perpetually commencing on May 04, 2015.

**ARTICLE IV: PURPOSE**

This corporation is organized with the general powers named in Chapter 607, Florida Statutes, currently in effect or as amended, to include but not limited to the right:

#### **ARTICLE VII: INITIAL BOARD OF DIRECTORS**



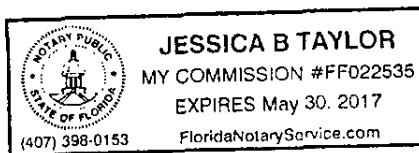
