ARTICLES OF DISSOLUTION

THESE ARTICLES OF DISSOLUTION (these "<u>Articles</u>") of SWIPE FINANCIAL, INC., a Florida corporation (the "<u>Corporation</u>"), are submitted to the Florida Department of State for the purpose of dissolving the Corporation, in accordance with Section 607.1403 of the Florida Business Corporation Act (the "<u>Act</u>").

1. The name of the corporation dissolved pursuant to these Articles is "SWIPE FINANCIAL, INC., a Florida corporation.

2. The effective date of the dissolution of the Corporation shall be December 31, 2015 (the "Effective Date").

3. The board of directors and the shareholders of the Corporation duly authorized the dissolution of the Corporation pursuant to Section 607.1402 of the Act. The number of votes cast in favor of dissolution of the Corporation by the shareholders was sufficient for approval.

4. As of the Effective Date, the Corporation does not have any debts, obligations or liabilities. Accordingly, all debts, obligations, and liabilities of the Corporation have been paid or discharged within the meaning of Section 607.1406 and Section 607.1407 of the Act, or adequate provision has been made therefore pursuant to Section 607.1406 and Section 607.1407 of the Act.

5. There are no suits pending against the Corporation in any court.
