**ARTICLES OF INCORPORATION OF
PENALTY SHOOTOUT TOURNAMENT, INC.**

ARTICLE I - Name

The name of this corporation is PENALTY SHOOTOUT TOURNAMENT, INC.

ARTICLE II - Street Address and Mailing Address

The street address and mailing address of this corporation is 7225 6th Avenue North, St. Petersburg, Florida 33710.

ARTICLE III - Purpose
