**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this corporation is Star Alliance Grove Inc. Its principal office address and business mailing address is 1395 Brickell Avenue, Suite 720, Miami, Florida 33131.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**
