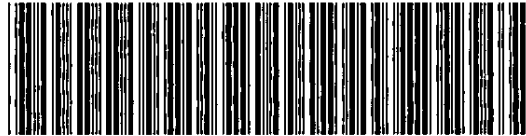

The name of this corporation is: FORTUNE CANVAS COMPANY, INC.
