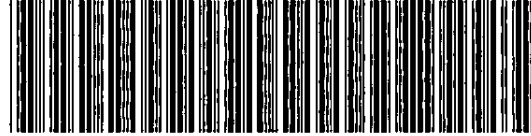

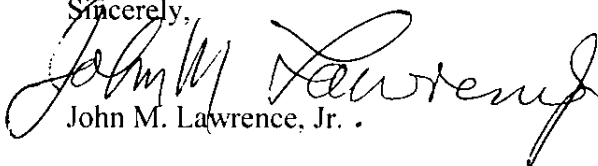

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is SYLVIANNA FASHION, INC. and its principal place of business shall be located at 4928 Cedarstone Ln, Orlando, FL 32822

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transaction any or all lawful business.

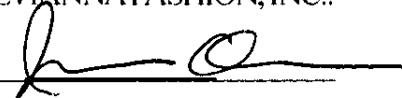

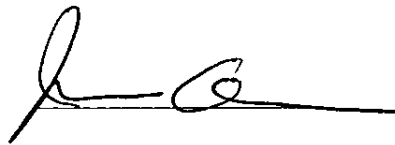
