**ARTICLES OF INCORPORATION
OF
NICHOLAS D. FUGATE, P.A.**

Pursuant to Chapter 621, Florida Statutes, the undersigned, being a natural person who is licensed to practice law in the State of Florida, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a professional corporation under the Professional Service Corporation and Limited Liability Company Act.

**ARTICLE I
(Name)**

The name of the Corporation ("Corporation") is Nicholas D. Fugate, P.A.

**ARTICLE II
(Principal Office)**

The street address and mailing address of the initial principal office of the Corporation is 2702 Masterson Lane, Tallahassee, Florida 32311.

**ARTICLE III
(Purpose)**

The purpose for which the corporation is formed is to engage in every phase and aspect of the practice of law through individuals licensed or otherwise legally authorized to practice law in the State of Florida. The corporation shall not engage in any business other than the rendering of legal services. The corporation may invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment, and may own real or personal property necessary for the rendering of professional services.

**ARTICLE IV
(Shares)**

The maximum number of shares this Corporation is authorized to issue is 10,000, par value \$.01 per share, all of which shall be Common Shares. Such shares shall be of a single class. None of the shares of the Corporation may be issued to anyone other than an individual duly licensed to practice law in the State of Florida.

**ARTICLE V
(Registered Office and Registered Agent)**

This initial street address of the Corporation's registered office is 2702 Masterson Lane, Tallahassee, Florida 32311. The initial registered agent for the Corporation at that address is Nicholas D. Fugate.


**ARTICLE VI

This number may be increased or decreased from time to time in accordance with the Corporation's Bylaws, but shall never be less than one. (Incorporator)**


