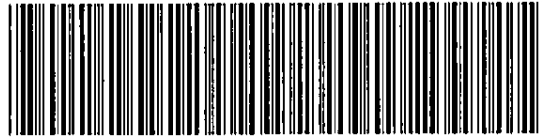

ARTICLE III.


The dissolution was authorized by the consent of all of the Corporation's directors and shareholders on February 3, 2023. The effective date of the dissolution shall be the date of filing.
