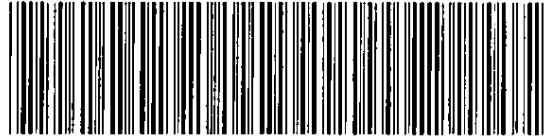




Dear Mr. Jorge Valladares and Alexis Del Toro
