ARTICLE I. NAME

The name of this corporation is ENDLESS SUMMER POOLS OF FLORIDA, INC.


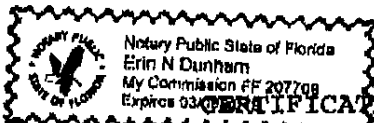

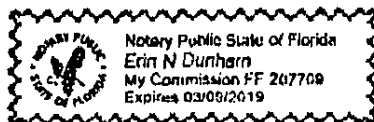
