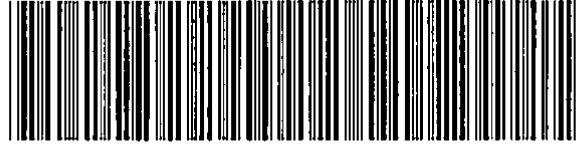

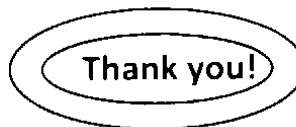

TO  
ARTICLES OF INCORPORATION  
OF

The undersigned, the President of **Monogram-VAF Loan Fund, Inc.**, a Florida corporation, (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation (Document Number P15000053132) pursuant to Section 607.1006, Florida Statutes this 21<sup>st</sup> day of August, 2019 states as follows:

1. The name of the corporation is **Monogram-VAF Loan Fund, Inc.**.
2. The Articles of Incorporation of the Corporation are hereby amended by striking out the first Article thereof and by substituting in lieu of said first Article the following language:

**Article 1**

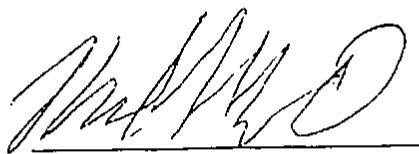
**NAME OF CORPORATION:** The name of the corporation (the "Corporation") is **Perdue-VAF Loan Fund, Inc.**.
