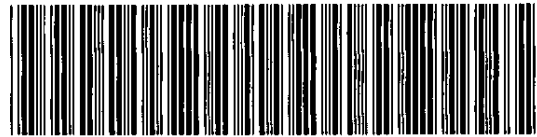

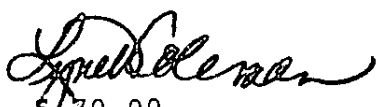

OF

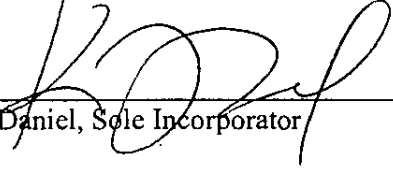
