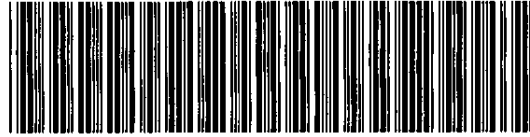



I, the undersigned, pursuant to Chapters 607 and 621, E.S. (For Profit), hereby execute the following ARTICLES OF INCORPORATION and set forth:

Article I. The name of the corporation is: American Home Inspections, Inc.

Article III. 
Article VI. The name of the Registered Agent is James M. Gruber, who is a resident of the State of Florida.
