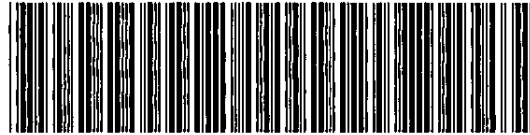

ARTICLE I:
