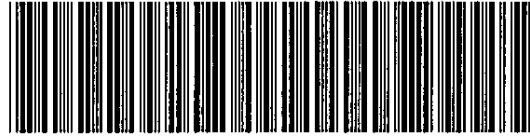

Article IV - Capital Stock; Number of Shares; Voting

The Corporation is authorized to issue Ten Thousand (10,000) shares of common stock One Dollar (\$1.00) par value per share, which shall be designated "Common Shares." Of the Common Shares, Five Thousand (5,000) shall be Class A Non-Voting Shares (the "Class A Shares") and Five Thousand (5,000) shall be Class B Voting Shares (the "Class B Shares").
