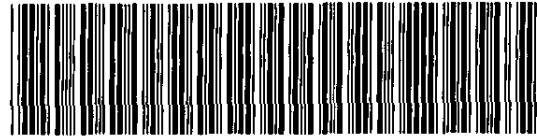

ARTICLES OF INCORPORATION

OF

Crum's Floor Covering Inc

The undersigned hereby form a corporation-for-profit under the Florida General Corporation Act by adopting the following Articles of Incorporation:

1. Name. The name of this corporation is Crum's Floor Covering Inc
2. Nature, Purpose and Powers. The corporation shall have perpetual existence, commencing the date these Articles are executed and acknowledged with the power to engage in any lawful business and have all powers enumerated in the Florida General Corporation Act.
3. Capital Stock. The corporation is authorized to issue 1,000 shares of \$.10 par value common stock.
4. Initial Registered Agent and Office. Kathryn Jackson is the corporation's initial registered agent at the registered office of 2930 Capital Medical Boulevard, Tallahassee, FL 32308.

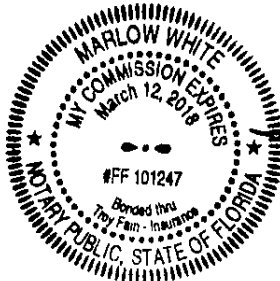

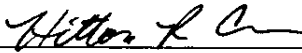

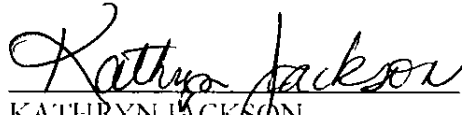
