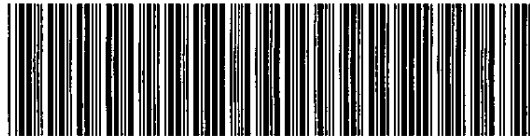

**ARTICLES OF INCORPORATION
OF
JS LAW GROUP, P.A.**

The undersigned incorporator, for the purpose of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of the corporation is JS LAW GROUP, P.A. and its principal place of business shall be located at 3642 N.W. 87 Avenue, Cooper City, Florida 33024.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State.

ARTICLE III – PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business. The general nature of the business to be transacting by this corporation is:

- A. To engage in every phase and aspect of the business of rendering the same professional services to the public that an attorney duly licensed under the laws of the State of Florida is authorized to render, but such professional services shall only be rendered through officers, employees, and agents who are duly licensed under the laws of the State of Florida to practice law therein;

- C. To do everything necessary and proper for the accomplishment of any of the purposes or attaining of any object or the furtherance of any purposes enumerated in these Articles of Incorporation or any amendment thereof.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of the corporation; and its hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purpose of the corporation otherwise permitted by law.

ARTICLE IV - CAPITAL STOCK

The maximum number of share of stock that this corporation is authorized to have outstanding at any one time is One Hundred (100) shares of common stock at one dollar (\$1.00) par value, which shall be designated as "Common Shares."




