The undersigned, acting as incorporator of Too Blue Industries, Inc., under the Florida Business Corporation Act, Florida Statutes Chapter 607, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is: **Too Blue Industries, Inc.** (the "Corporation").

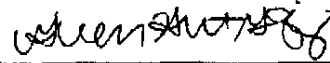

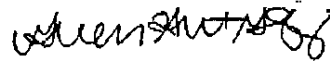
