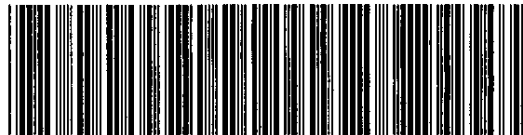

**ARTICLE I.  
NAME**

The name of this corporation is V-I-A, INC.

**ARTICLE II.  
DURATION**

The period of existence of the corporation is perpetual.

**ARTICLE III.
