The undersigned, acting as incorporator of WATERFLY FLORIDA, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is WATERFLY FLORIDA, INC. (the "Corporation").


ARTICLE IX. BYLAWS
