ARTICLES OF INCORPORATION OF ASSURANCE LAW GROUP, P.A.

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract under the laws of the State of Florida, hereby presents these Articles for the formation of a Corporation under Florida Statutes, Chapter 621, Professional Service Corporation and Limited Liability Company Act, and other laws of the State of Florida.

ARTICLE I. NAME

The name of this Corporation is ASSURANCE LAW GROUP, P.A. (the "Corporation").

ARTICLE II. NATURE OF BUSINESS

The Company is organized for the sole and specific purpose of rendering professional services as licensed attorneys at law.

ARTICLE III. CAPITAL STOCK

Every amendment shall be approved by the Board of Directors, proposed by them to the Stockholder(s), and approved at a Stockholder(s) meeting by a majority of the stock entitled to be voted thereon unless all Directors and all the Stockholder(s) sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made; however, in no event may any amendment provide that the Corporation may enter into any stock repurchase plan or issue any new shares without first acquiring the unanimous consent of all of the Stockholder(s). All rights of Stockholder(s) are subject to these reservations.
