ARTICLE I
CORPORATE NAME

CORPORATE POWERS**

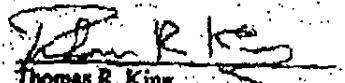
This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

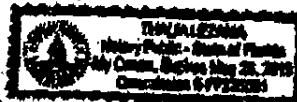
