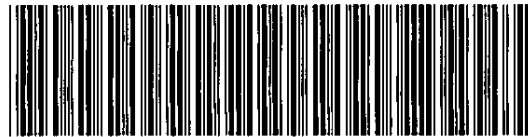

**ARTICLES OF INCORPORATION
OF
US SHREDDER AND CASTINGS GROUP, INC.**

The undersigned incorporator, William H. Tigner, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation for profit under the provisions of Chapter 607, *Florida Statutes*.

ARTICLE I - NAME

The name of the corporation shall be US Shredder and Castings Group, Inc. (the "Corporation").

ARTICLE II - PRINCIPAL OFFICE

The street and mailing address of the Corporation's initial principal office is 755 Grand Blvd., Suite B105-328, Miramar Beach, Florida 32550.

ARTICLE III - PURPOSE AND POWERS

The Corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States. 
