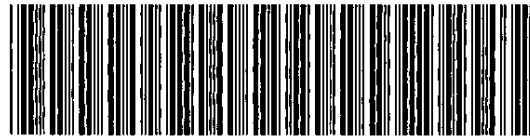

ARTICLE I


