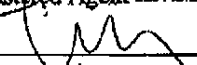

We have will NOT be reinstating the dissolved business,(Fabrizi Holdings, LLC).

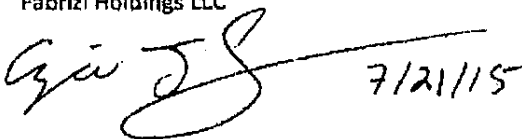

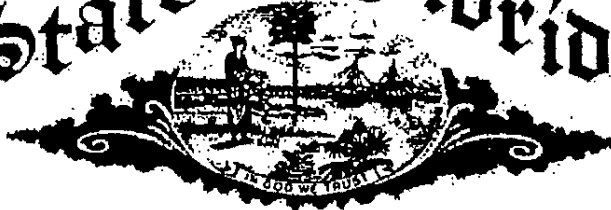
