ARTICLES OF INCORPORATION OF CHADBOURNE MEDICAL CONSULTANTS, P.A.

The undersigned incorporator, Chadbourne Medical Consultants, P.A., to these Articles of Incorporation, being a natural person competent to contract, and duly licensed to render services as a doctor of medicine under the laws of the State of Florida, hereby form a corporation for profit under the Professional Service Corporation Act and other laws of the State of Florida.

ARTICLE I

Name

The name of this Corporation is Chadbourne Medical Consultants, P. A. The street address of the Corporation is 5984
Old Dixie Highway, Grant, Florida 32949.

ARTICLE II

Term of Existence

This Corporation shall have perpetual existence, commencing with the filing of these Articles of Incorporation.

ARTICLE III

Purpose

The general nature of the business to be transacted by this Corporation is:
