ARTICLE I

Name

The name of the corporation shall be **Coosaw Rod And Gun Club, Inc.**

ARTICLE II

Duration

The duration of the corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing the Articles of Incorporation by the Department of State of the State of Florida.

ARTICLE III

Purpose

The purposes for which the corporation is organized are: to operate as a sporting club for hunting, fishing and related outdoor activities, such other outdoor activities as may be appropriate, and to do everything necessary, proper, advisable or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the corporation laws or by any other law, or by these articles of incorporation. The hunting club and its activities shall be in South Carolina, or such other location as may be determined by the Board of Directors.

ARTICLE IV

Principal Office And Registered Agent

The street and mailing address of the principal office of the corporation is Tyrie W. Boyer, 2234 River Road, Jacksonville, Florida 32207. The name and address of the initial registered agent of the corporation is: Tyrie W. Boyer. Registered Office: 2234 River Road, Jacksonville, Florida 32207.

ARTICLE V

Board of Directors; And Officers

The business and property of the corporation shall be managed by a Board of Directors. The number of Directors constituting the initial Board is one and the name and address of each person who is to serve as a member thereof, until or unless their successors are elected and qualified, and the office to be held by each are as follows:

Article VI

Capitalization

The aggregate number of shares that the corporation shall have authority to issue is 7,500.00 shares of capital stock with par value of \$1.00 per share. The shareholders of the corporation shall have preemptive rights with respect to the issue of further stock.

DIVIDENDS. The holders of the outstanding capital stocks shall be entitled to receive, when and as declared by the Board of Directors, dividends payable either in cash, in property, or in shares of the capital stock of the corporation.

The shares of the corporation do not have to be divided into classes. The corporation is not authorized to issue shares in series.

Article VII

Shareholders

A majority vote of the shareholders of the corporation shall be required for any shareholder action.

The shareholders shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a stockholders' meeting, with a vote of two-thirds of the stockholders of the corporation.

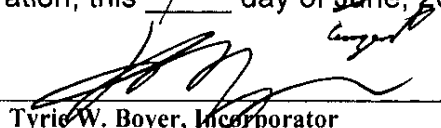

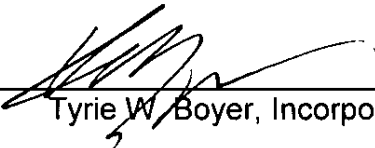
