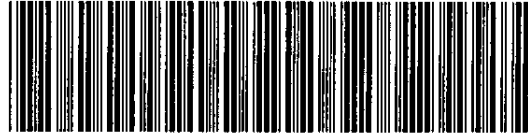



ARTICLES OF INCORPORATION OF

GSJ BAKERY INC.

ARTICLE I Name of Corporation

The name of this corporation is GSJ BAKERY INC.

ARTICLE II Purpose

Incorporated primarily as a food service provider, GSJ BAKERY INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.



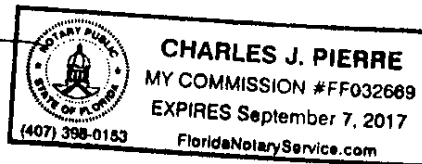
