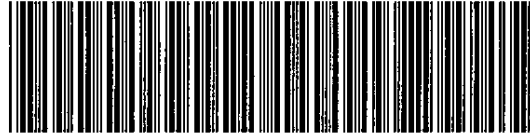

ARTICLES OF INCORPORATION

I.

The name of the corporation is "NETMOR DIRECT, INC."

II.

The corporation is organized pursuant to the provisions of the Florida Business Corporation Act.

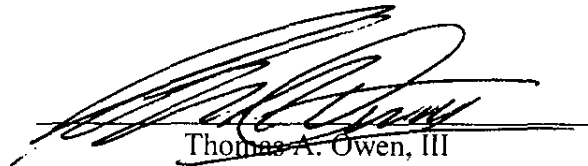
