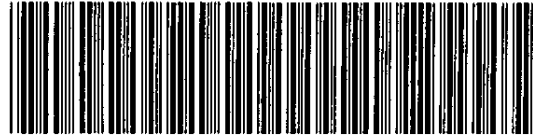


AMENDMENT

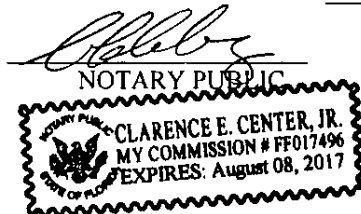
