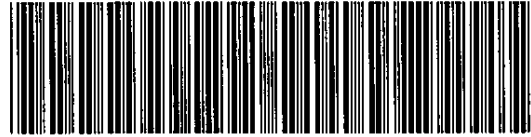


ARTICLE IV



FIRST: The Partnership was formed on December 30, 2014 under the laws of the State of Florida.


