OF

ARTICLE I

The name of this Corporation shall be: Gulf Coast Eye Clinic for Animals, P.A., and its initial mailing address shall be: 4064 Platt Street, North Port, Florida 34286. The initial street address of the Corporation's principal office shall be: 4064 Platt Street, North Port, Florida 34286.

ARTICLE II

The purpose of this Corporation is to engage in the practice of veterinary medicine, and render professional services within the State of Florida and to take all actions that are necessary or proper in connection with that practice.


