## ARTICLES OF DISSOLUTION OF FIRST GREEN FUNDING, INC.

First Green Funding, Inc. (the "Corporation") does hereby set forth the following in connection with the dissolution of the Corporation pursuant to Sections 607.1401, et. al., of the Florida Business Corporation Act:

FIRST: The name of the corporation to be dissolved is First Green Funding, Inc.

SECOND: The document number of the corporation is P15000076794.
