STATE OF FLORIDA ARTICLES OF INCORPORATION OF Mzong Express, Inc.

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

> ARTICLE I Name

The name of the Corporation is Mzong Express, Inc.

ARTICLE II Principal Place of Business


